使用方法:

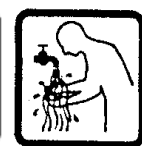
只供殺草用途，
不可作其他用途

使用要點：

- ◇ 將 10ml“草絕”投入 5 公升水中搖勻，稀釋比率為 500 倍，噴灑 10m² 農地。
- ◇ 使用清水來混合。若使用污水會降低除草劑之效果。混合時要均勻。
- ◇ 建議用於非種植地區或工業地區如排水和灌溉渠道，路邊，鐵路，行人道和康樂場地用來全面消滅雜草。
- ◇ 避免噴霧飄落在其他的農作物。避免作物的葉，莖，果實及植物和樹木與藥液飄散在空氣中的藥霧接觸，否則會使它們產生嚴重的損傷或毀壞。
- ◇ 收穫前十四天停止使用。
- ◇ 防治對象：非選擇性殺草劑，用於清除雜草。
- ◇ 相容性：不建議與其他除草劑混配使用。

Control Method:

- ◇ Put 10ml “Troop” directly into 5 liter of water with dilution rate in 500 times. Mix well and spray directly to 10m² farm land.
- ◇ Use clean water for mixing. Dirty water can reduce the effectiveness of herbicide. Mix thoroughly.
- ◇ Recommend to use in non-crop or industrial areas such as drainage and irrigation canals, roadsides, railways, walkways and recreational area for total vegetation control.
- ◇ Avoid spray mist drift on the crops nearby. Avoid contact of spray drift with foliage, green stems, or fruit of crops, desirable plants and trees, since severe injury or destruction may result.
- ◇ Stop application 14 days before harvesting.
- ◇ Control target : Non-selective herbicide. For killing weeds.
- ◇ Compatibility : Mixing with other herbicide is not recommended.



注意事項：應小心遵守產品注意事項及使用方法

- ◇ 對人畜有害
- ◇ 如誤服、吸入或透過皮膚滲入會有害。
- ◇ 使用前必須參閱及了解標籤指引
- ◇ 必須依照標籤上特定之用途小心使用。
- ◇ 請依照建議的使用量，避免過量使用。
- ◇ 不要稀釋過多即時所需的除害劑，使用前搖勻。
- ◇ 使用時，不可飲食及吸煙。
- ◇ 小心噴霧，切勿吸入避免接觸口，眼睛，皮膚及衣服。
- ◇ 不要用空間噴灑方法施用。
- ◇ 不要使用鐵或鍍鋅容器來處理及儲存此除害劑。
- ◇ 對魚類及水中生物有害，切勿污染水源。
- ◇ 勿使藥劑沾染在其他農用化學品上。
- ◇ 使用前，勿讓未經授權人仕進入施藥地點
- ◇ 用不同的噴霧器分別施放殺蟲劑及除草劑，並在噴霧器上加上明顯的標記以便易於辨別。
- ◇ 孕婦及對此農藥敏感之人不宜施藥。
- ◇ 施藥前後，應在周圍的當眼處加上警告告示（如毒藥，不准進入，除害劑名稱，施藥日期及時間等）
- ◇ 在施藥後的十二小時內，不可進入或讓工人再次進入施藥範圍
- ◇ 使用時須時刻穿著保護性衣物及器具（如工作服，護目鏡，聚氯乙烯手套或呼吸器等）
- ◇ 使用後須徹底清洗雙手。
- ◇ 不可貯存在接近明火、發熱裝置、電暖爐、陽光照射或高熱的地方(或暴露於溫度高過室溫的地方)。
- ◇ 貯存在遠離食物的地方。
- ◇ 不可將容器作其他用途。

急救方法

如誤服：切勿催吐，應帶同產品說明，前往醫治

如皮膚沾上：用肥皂或洗潔精及大量清水沖洗，若情況沒有好轉，即前往醫治

如眼睛沾上：用大量清水沖洗，若情況沒有好轉，即前往醫治

如吸入：將傷者移離現場往空曠地方，若情況沒有好轉，即前往醫治

解毒劑：無特定解毒劑 請按徵狀醫治

送院診治時，必須帶同此標籤。

存放

小心鎖藏，遠離食物、飲料、飼料、孩童及動物。須存放在緊閉的有標籤原裝容器內，並置於陰涼乾燥處。必須與殺蟲劑分開存放

棄置容器

除害劑用完後，不可將容器作其他用途。清洗容器後之殘餘除害劑不可污染水源，應將其加入噴霧器內再作使用。應根據香港法例第 354 章廢物處理條例來處理不需要的除害劑廢料

毒藥 POISON

PRECAUTIONS: The Directions for Use and Precautions of this product must be followed carefully.

- ◇ Hazards to humans and animals
- ◇ Harmful if swallowed, inhaled or absorbed through skin.
- ◇ Read and understand the label before using.
- ◇ This pesticides product should only be used for purposes as specified on the label.
- ◇ Follow the recommended application rate and avoid excessive wetting of applied areas.
- ◇ Do not dilute pesticide more than necessary for immediate use. Shake well before use.
- ◇ Do not eat, drink and smoke while spraying.
- ◇ Beware of spray mist, avoid inhale, contact with mouth, eyes, skin and clothing
- ◇ Do not apply using space spray method.
- ◇ Do not use iron or galvanized container to process or store this herbicide.
- ◇ Toxic to fish and aquatic organism. Do not contaminate water source
- ◇ Do not contaminate other farm chemical with the product
- ◇ During application, make sure unauthorized personnel is inaccessible to the treated area
- ◇ Use separate, clearly marked sprayers for insecticides and herbicides
- ◇ Pregnant or sensitized persons should not apply pesticides
- ◇ Before and after application, warning notices (e.g. POISON, NO-ENTRY, Name of Pesticide, Date and time of application, etc) should be posted at conspicuous location.
- ◇ Do not enter or allow worker entry into treated areas during the restricted entry interval of 12 hours.
- ◇ Wear protective clothing and equipment (e.g. overalls, goggle, PVC gloves and respirator etc.) at all times when handling pesticide.
- ◇ Beware of spray drift, do not inhale the mist, avoid contact with mouth, eyes, skin and clothing.
- ◇ Wash hands thoroughly after use.
- ◇ Do not place or store the container near fire, heater, electrical warmer or heated areas (or at place where temperature is above Room temperature).
- ◇ Store away from food.
- ◇ Do not re-use the empty container for any other purposes.

STORAGE

Always keep the pesticide in the original labeled container and store in a cool, dry and safe place under lock and key and away from food, drink, feedstuffs, children and animals. Store away from insecticides

DISPOSAL OF CONTAINER

Do not re-use this container for any other purpose. Add the rinsing to the spray mixture for reuse, do not pour into the waterways. Any unwanted quantity must be disposal of in accordance with requirement laid down in the Waste Disposal Ordinance Cap.354.

FIRST AID

If swallowed: Do not induce vomiting, bring the product label and get medical attention

If on skin: Use detergent and wash the area with a lot of water. If problem persist, get medical attention.

If in eyes: Wash with a lot of water, If problem persist, get medical attention.

If inhaled: Remove the affected victim from expose to an area of fresh air Keep at rest. If problem persist, get medical attention.

ANTIDOTE: No specific antidote. Treat symptomatically
Always bring along the label when seeking medical attention.
